Directions:

From Interstate 64, take the Midway exit (going East head right, going west head left off of freeway). At the dead end turn Right on 421 (Leestown Road). Go about 1 ½ miles down Leestown, first street turn Right on Fishers Mill Road. This is a narrow road, drive slowly around turns, farm is about a mile and half down road on right hand side. You will pass the entrance to the Fishers Mill Sub-division. There is a sign up front that says Springwood Farm and the address is 1620 Fishers Mill Road. The gates are automatic, just pull forward and they will open. Follow the signs around the fountain, down the drive to the left and park in big field.

From New Circle, exit Leestown Rd., head out of town towards Midway. Stay on 421 (Leestown Road) until you reach Fishers Mill, turn Right on Fishers Mill then follow the directions above.

Ribbons: 1st through 6th All divisions & Jumper classes
Awards or Prizes handed out to all 1st Place competitors.
Prize Money awarded in Jumper Classes EXCEPT (1a)- 1st place- \$15, 2nd - \$10, 3rd - \$5. Must have 6 entries per class for prize money.

CLASS INFORMATION

Jumper Classes: Will be different courses from the combined test.
Table 2, Sec 2b - First Round & Jump Off - If competitor has gone clean in the first round, the competitor without leaving the ring, upon an audible signal, commence the designated jump off course.
All classes are open to everyone. There is no limit to how many classes you would like to enter.
